## **Employment Opportunity**

Halifax Water is Atlantic Canada's largest water utility, providing integrated water, wastewater and stormwater utility for more than 106,000 customers daily. For more than 70 years we have been proud stewards of the water cycle, providing clean water to customers, and safely conveying it back to the source. Through our One Team - One Water approach, our more than 550 dedicated employees provide essential water services to an estimated 383,000 people in HALIFAX.

Halifax Water is hiring for the job of **Water Treatment Plant Day Operator**. This is a **regular, full-time opportunity** in the Operations Department. Working a day shift, the Day Operator takes a lead role in performing and organizing preventative maintenance. The Day Operator will replace scheduled water supply plant operators as assigned. When not working in the capacity of a shift operator, the Day Operator will work the same hours as other day workers as per the CUPE 227 collective agreement.

### As a Water Treatment Plant Operator, you will:

- Under the direction of the Plant Supervisor, the Day Operator works as one of a team of operators at the assigned plant, including the pumping station, dam, nearby properties, and emergency water supplies.
- Take a lead role in performing and organizing preventative maintenance on all facility mechanical equipment. Perform regular maintenance checks on all facility equipment making minor adjustments and scheduling other maintenance.

- Ensures all responsibilities are met as it pertains to the ISO 14001 compliant
  Environmental Management System for the entire scope of the certification and established standard operating procedures.
- Under the direction of the Supervisor, Water Supply Plants, perform periodic checks and inspection on the emergency water supply and other emergency equipment.
- Monitor and control all operational processes during the shift period. Make process adjustments as required. Take samples and make routine tests for process control. Take regular readings, maintain operational log book and log any irregularities.

### To do this job, you need to have:

- Two (2) year technical program related to Water Treatment (or a one-year technical program related to water treatment plus specialized industry training courses or sufficient CEUs may be considered). An equivalent combination of formal education and related experience in a water treatment environment may be considered
- The successful incumbent must have a minimum of five years related experience including three years working in a water treatment plant
- Must possess a Class 3 Water Supply Plant Operator Certificate
- Valid NS driver's license
